### OVERALL ASSEMBLED DIMENSIONS

- CUP:** PLATED STEEL, 1 MM THICK, 6.5 CM (2-1/2") DIA. x 4.3 CM (1-3/4") HEIGHT. SHAPED AS SHOWN.
- SHADE:** WHITE ALABASTER GLASS, 17.8 CM (7") DIA. x 10.6 CM (4-1/8") HEIGHT. SHAPED AS SHOWN.
- ARM:** PLATED STEEL TUBING, 13.5 CM (5-1/4") WIDTH x 15.2 CM (6") HEIGHT. SHAPED AS SHOWN.
- SUPPLY WIRE:** UL LISTED. 18 AWG, 105', MUST EXTEND A MINIMUM OF 15.2 (6") PAST CENTER OF BACKPLATE. WIRES MUST BE LEAD FREE.
- LABEL:** UL AND CSA OR CUL, MANUFACTURING DATE, MODEL # AND COUNTRY OF ORIGIN LABELS PROVIDED ON BACKPLATE. RELAMPING LABEL FOR 100 WATT TYPE "A" BULB PROVIDED ON SOCKET OR NEAR SOCKET.

### PACKAGING AND SHIPPING

- THE ITEM IS DISASSEMBLED FOR SHIPPING AS SHOWN. EACH PART IS SECURED SO THEY CAN NOT MOVE DURING SHIPPING.
- HARDWARE PACK #005 PROVIDED. ENTIRE FIXTURE IS COVERED IN A CLOSED PLASTIC BAG WITH A SMALL BAG OF SILICA INSIDE.
- THE CARTON IS MADE OF DOUBLE WALL CORRUGATED CARDBOARD "A MA A". BROWN IN COLOR. THE INNER PACKING IS DIE-CUT CARDBOARD OR STYROFOAM TO PROTECT AND SECURE THE FIXTURE AND MUST PASS THE SPECIFIED DROP TEST REQUIREMENTS.
- EACH CARTON SHALL BE PRINTED WITH A LINE DRAWING AND THE KENROY HOME NAME AND LOGO, MODEL NUMBER, SKU NUMBER AND FINISH, EACH CARTON SHALL BE PROVIDED A UPC LABEL. THE UPC BAR CODE AS FOLLOWS: BS=053392186265.
