## PACKAGING AND SHIPPING DETAILS

- THE FIXTURE IS DISASSEMBLED FOR SHIPPING. EACH PART IS WRAPPED IN A PLASTIC BAG WITH A SMALL BAG OF SILICA AND PACKED IN ITS OWN CARDBOARD CARTON.
- HARDWARE PACK #001 IS PROVIDED. ALL PARTS SHOULD BE SECURED SO THEY CAN NOT MOVE DURING SHIPPING.
- THE CARTON IS MADE OF A DOUBLE WALL CORRUGATED CARDBOARD "A MA A". BROWN IN COLOR. THE INNER PACKING IS DIE-CUT CARDBOARD OR STYROFOAM SUFFICIENT TO PROTECT AND SECURE THE FIXTURE AND MUST PASS THE SPECIFIED DROP TEST REQUIREMENTS.
- EACH CARTON SHALL BE PRINTED WITH A LINE DRAWING AND THE KENROY NAME AND LOGO, MODEL NUMBER, SKU NUMBER AND FINISH, EACH CARTON SHALL BE PROVIDED A UPC LABEL. THE UPC BAR CODE AS FOLLOWS: BS=053392186241.
